Each program will start on Monday, September 28th and end on Thursday, June 3rd. University scheduled breaks and holidays will be observed. Additionally, the program will reserve Wednesday, November 25th as a program holiday.

All families are expected to **attend the virtual Fall Parent Orientation Meeting**. You will be notified of specific date and time.

Enrollment

Enrollment: This *Contract/Informed Consent* and the *Family Information Form* **must be completed** before your child begins the virtual learning program. Materials are to be submitted to the Administrative Assistant at the ECL Administrative Office.

Tuition and Fees

Tuition is set as a flat monthly rate; we are unable to offer decreased tuition rates for currently enrolled UC Davis student families. Monthly billed rates:

- Prekindergarten and Transition Preschool Virtual Learning Program: \$102.40
- Toddler Family Group Time: \$76.80
- Once annual nonrefundable Administrative Fee: \$45.00 added to 1st month’s tuition

Deposit: the final three weeks of tuition must be paid in advance of program participation as a registration deposit (due August 15, 2020). This pre-paid tuition will be applied to the spring quarter or final bill, whichever comes first.

- Prekindergarten and Transition Preschool Virtual Learning Program: \$76.80
- Toddler Family Group Time: \$57.60

\$20 per quarter for individual play kit supplies.

Program Withdrawal

Families must provide the ECL Director with a written 30-day notice for program withdrawal.

Online Parental Consent Form

The ECL Virtual Learning Program will utilize the Zoom platform for engaging children in remote learning experiences, and for conferencing with families. While we feel that there is no real substitution for face-to-face instruction and interaction, we want to continue offering children and families high-quality early learning experiences.
